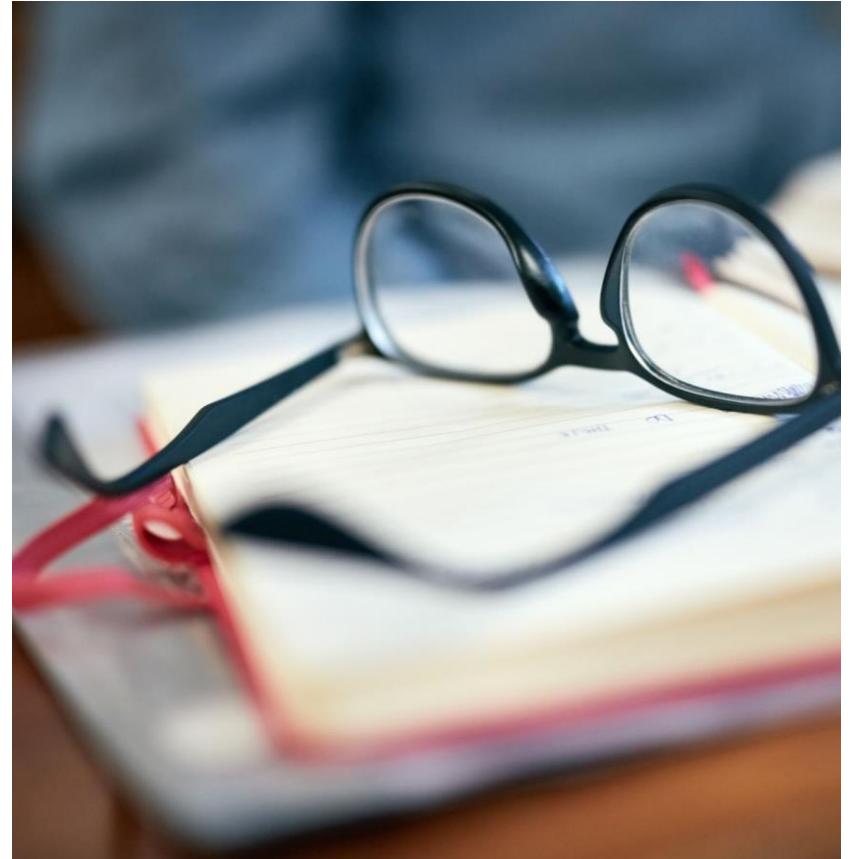

# Duties of University Teachers: Jahangirnagar University Act, 1973 (section 21 of 1<sup>st</sup> Statute)

---

- i. to teach the students by means of lectures, tutorials, discussion, seminars, demonstrations and in like manner;
- ii. to conduct, guide and supervise research;
- iii. to maintain personal contact with the students, give them individual guidance and supervise their extra-curricular activities;
- iv. to assist the authorities in preparing courses and syllabuses, in conducting examinations, in organizing libraries and other curricular and extra-curricular activities of the University and its departments;
- v. to perform such other functions and discharge such other academic duties as may be assigned to them by the Vice-Chancellor.

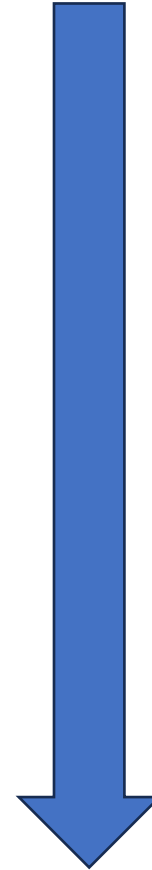

## Standard 1: Governance, Efficient Management

---

**Criterion 1-1:** Defined vision, mission of the PoE

---

**Criterion 1-2:** Well-communicated strategic plan to achieve the objective

---

**Criterion 1-3:** Have set up to receive complaints and redress issues including sexual harassment.

---

**Criterion 1-4:** The PoE has to maintain the academic calendar of all academic activities.

---

**Criterion 1-5:** The PoE has a class size policy to ensure better attainment of learning outcomes.

---

**Criterion 1-6:** The PoE/HEI maintains IT based student database with details.

# Criterion 1.1: Documentation and Evidence





## Criterion 1.2: Documentation and Evidence

- i) A copy of the documented strategic plan with strategic goals, objectives, necessary actions, and implementation plan including a specific timeline with budget and indicators to measure the achievements.
- ii) Minutes of the meeting relating to approval of the strategic plan
- iii) Mechanism or system to collect input from the stakeholders for preparing the strategic plan.
- iv) Minutes of the meeting relating to the way inputs from faculty, staff, and other stakeholders were considered in preparing the strategic plan.
- v) Communication link that shows the way the strategic plan is communicated among the concerned stakeholders

# Standard 2: Leadership, Responsibility and Autonomy



To be responsive to the emerging changes and needs, the PoE/HEI must have effective leadership and sufficient autonomy.



**Criterion 2-1:** The HEI/PoE has an organizational structure with well defined responsibilities.



**Criterion 2-2:** The PoE has sufficient autonomy with financial support to organize academic activities.



**Criterion 2-3:** The PoE maintains a set of values to foster social responsibility, diversity, and inclusivity.

# Standard 3: Institutional Integrity and transparency



The PoE/HEI must act responsibly to meet the needs of the stakeholders to manage the academic program.



**Criterion 3-1:** The HEI/PoE must have a well-defined policy for the recruitment of faculty and professional staff.



**Criterion 3-2:** HEI/PoE has to maintain a well-defined code of conduct for the students, faculty, and staff and policy to promote and recognize moral values and ethical practices.



**Criterion 3-3:** The admission process ensures transparency and fairness.

## Standard 3: Institutional Integrity and transparency



**Criterion 3-4:** HEI/PoE has to publish regularly a student handbook containing the mission and objective of PoE, curriculum, graduate profile, academic calendar, disciplinary rules, and academic and examination rules.



**Criterion 3-5:** The HEI/PoE has a well-designed and informative website with easy access for all.



**Criterion 3-6:** The HEI/PoE: has a well-defined policy to address student grievances and complaints.



# Standard 4: Curriculum

**Curriculum must be outcome based and consistent with BNQF**

**Criterion 4-1:** The curriculum of the program has to be prepared as required by BNQF.

**Criterion 4-2:** Curriculum aims at producing graduates focusing on graduate profile.

**Criterion 4-3:** Program Learning Outcomes (PLOs) are defined within the scope of the mission and objectives of PoE.

**Criterion 4-4:** Program learning outcomes (PLOs) are specific, measurable, and time-bound.

# Standard 4: Curriculum

Criterion 4-5: The curriculum has to comply with the qualification's framework in terms of credit and credit value.

Criterion 4-6: Program learning outcomes and courses are aligned to make the content appropriate and adequate.

Criterion 4-7: For a Bachelor's degree, the course content should have at least 25% general education courses.

Criterion 4-8: The PoE has to maintain a documented course file stating all academic activities.

Criterion 4-9: Internship/Project/dissertation/fieldwork have to be integrated into the curriculum.

# Standard 5: Teaching-Learning & Assessment

Teaching learning practices have to be systematic, innovative practice oriented to attain learning outcomes. Must have mechanism to trace students' progress.

**Criterion 5-1:** Teaching-learning and assessment method should prepare students with critical thinking and develop higher order thinking skills (HOTS).

**Criterion 5-2:** Students learning time (SLT), teaching-learning and assessment activities are in accordance with the credit of that course and has cover all course learning outcomes.

**Criterion 5-3:** Course teacher has to maintain class schedule records of missed and make up classes.

**Criterion 5-4:** Course plan should be made available to all students from the beginning.

**Criterion 5-5:** Students have to get timely feedback on their performance for future final/summative tests.

# Standard 5: Teaching-Learning & Assessment



Criterion 5-6: Question papers for semester final examination are moderated by the examination committee composed of internal and external examiners.



Criterion 5-7: PoE has to maintain clearly defined progression rules, for moving from one semester to another.



Criterion 5-8: Course learning outcome, teaching-learning activities, and assessment methods are properly aligned in all courses of the program.



Criterion 5-9: PoE maintains provisions of tutorial classes for each course for the attainment of course learning outcomes.

# Standard 6: Student Admission & Support Services

---

**The HEI/PoE must set appropriate entry requirements and select the right candidates for a particular program.**

---

**Criterion 6-1:** The HEI/PoE must maintain a clearly defined well communicated admission policy.

---

**Criterion 6-2:** The HEI/PoE has to maintain a separate administrative set up for all admission as well as of international students.

---

**Criterion 6-3:** A well-structured student affairs office to take care of issues like health care, stress management, food safety, hygienic, vaccination etc. for sound physical and mental growth.

---

**Criterion 6-4:** PoE has to organize orientation program for students to acquaint them with academic program, facilities, career prospects, and pathways at the start of the program.

# Standard 6: Student Admission & Support Services

**Criterion 6-5:** The students have to be aware of course contents, good conduct, and disciplinary actions for cheating, plagiarism, cyber-crime etc. under a well-defined policy.

**Criterion 6-6:** A well organized alumni association of the PoE is a pleasant support for all PoE, students and the staff.

**Criterion 6-7:** PoE has to ensure participation of students in co-curricular activities and community services for promoting creativity, social responsiveness, leadership qualities etc. for holistic development.

**Criterion 6-8:** PoE/HEI has to organize career counseling and guidance sessions and support them in placement on a regular basis.

**Criterion 6-9:** There must be student progress and achievement monitoring system and also to identify students facing problems.

# Standard 7: Faculty and Professional Staff



The HEI/PoE must have a policy to ensure the availability of adequate qualified faculty and professional staff with a reasonable teacher-student ratio.



**Criterion 7-1:** The PoE has to maintain suitably qualified, skilled, and experienced faculty to facilitate the attainment of learning outcomes.



**Criterion 7-2:** The PoE/HEI has to maintain a salary structure with incentives to retain talented faculty and staff.



**Criterion 7-3:** The HEI/PoE has a policy to support the faculty for higher studies and training.



**Criterion 7-4:** HEI/PoE supports and motivates the faculty to attend seminars, training, workshops, conferences etc. at home and abroad for professional development.

# Standard 7: Faculty and Professional Staff

- **Criterion 7-5:** A well-defined system has to be there to evaluate the performance of faculty and staff at three levels: (i) Head of PoE (ii) Students and (iii) Self-evaluation.
- **Criterion 7-6:** The HEI/PoE maintains a workload distribution policy balancing teaching, research, and administrative activities.
- **Criterion 7-7:** The HEI/PoE has to have provision to appoint competent persons as guest speakers/adjunct faculty for bridging the gap between the academic and industry.
- **Criterion 7-8:** The PoE maintains an ideal combination of faculty with 10% Professor, 20% Associate Professor, 40% Assistant Professor, and 30% Lecturers.



# Standard 8: Facilities & Resources

The HEI/PoE must ensure availability and access to the appropriate and adequate facilities and resources necessary for effective teaching-learning.

**Criterion 8-1:** The PoE has to maintain a policy for student enrollment in terms of capacity and facilities available.

**Criterion 8-2:** The HEI/PoE has to have well well-equipped library with a proper management system and online access to books and journals.

**Criterion 8-3:** Necessary physical facilities like office service, computer lab, fire and safety, canteen, washroom, prayer room etc. will have to be there for congenial academic environment.

**Criterion 8-4:** Appropriate laboratory facilities, with manuals, and IT facilities in good condition should be made available.

**Criterion 8-5:** The HEI/PoE has to have resources under a clear policy to run the academic activities smoothly.

# Standard 9: Research & Scholarly Activities



The HEI/PoE must support and promote need-based quality research for the greater benefit of the stakeholders and society.



**Criterion 9-1:** A comprehensive research policy has to be there with proper mechanisms to control plagiarism. The HEI/PoE must develop a research culture and mechanism to appropriate outstanding research.



**Criterion 9-2:** The HEI/PoE has to take the initiative to do need-based research focusing on local and global issues wherever possible with external collaboration.



**Criterion 9-3:** The HEI/PoE has to maintain a policy to disseminate and transfer the research findings to the industry/community through extension service.



**Criterion 9-4:** The PoE is expected to produce high-quality publications with a commitment to have an impact on the community and society.

# Standard 10: Monitoring, Evaluation & Continual improvement

The HEI/PoE must have a policy to monitor and review the policies and practices to identify strengths, weaknesses, opportunities, and threats (SWOT) for sustainable quality assurance and continual improvement.

**Criterion 10-1:** Well-functional institutional Quality Assurance Cell (IQAC) has to be there within the organizational set-up of the HEI.

**Criterion 10-2:** There has to be a system of collecting feedback from the stakeholders and also a mechanism to address them, issue may be like changes in industry, the effectiveness of the course, the performance of teachers, the non-functioning of facilities, etc.

**Criterion 10-3:** The program has to be continually monitored, reviewed, and updated on feedback received, so that it is dynamic and sustainable.

**Criterion 10-4:** The HEI/PoE has to maintain university-industry collaboration (UIC) for mutual benefit and improvement.

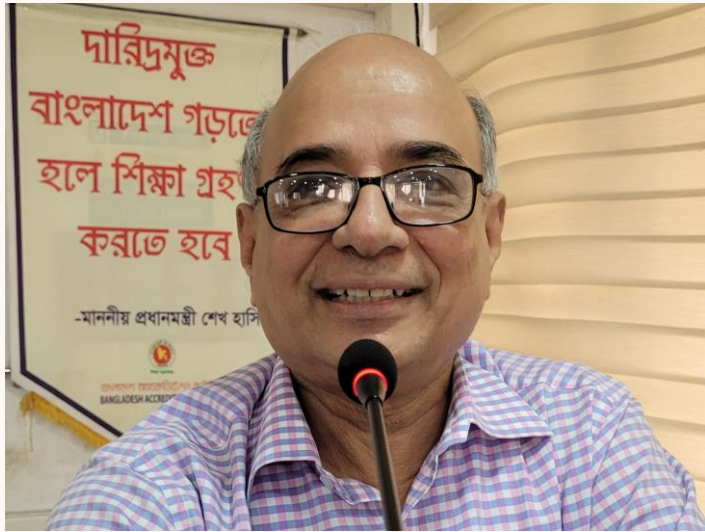
